

## Concord Township Board Minutes

The Concord Township Board met in the Common Meeting Room April 11, 2016, at 7:30 P.M.

The meeting was called to order by Supervisor Ley at 7:30 P.M. and The Pledge of Allegiance was honored.

Clark presented the board with the March 9, 2016 Concord Township Board minutes for approval. Jacokes made a motion to accept the minutes, Ley supported. Motion carried.

Public comments:

Amy Robertson did a presentation on the Annexation of Albion Schools Annexation; Dr. Allan Tompkins introduced himself as he is running for County Commissioner.

Clark presented the Board with the March bills in the amount of \$20,398.48. Clark made a motion to accept the bills as submitted. Ley supported. Motion carried.

Fire report was given by Clerk Clark. Reported that Chief Mosher gave out a report that listed 11 years' worth of runs and cost for each the Township and the Village. Not sure what this will be used for and will be discussed at the April Fire Board meeting.

Chief Munster gave the March 2016 police report with 47 complaints, 4 citation, 5 arrests, Suspended License, Improper use of Plates and 3 warrants. March miles driven were 1,401. Chief Munster was a Guest reader for the 4<sup>th</sup> grade and gave 2 K9 Demos at the Hanover Horton Elementary 1<sup>st</sup> grade classes.

Ley made a motion to accept the reports as presented. Miller supported. Motion carried.

Mower at cemetery has been fixed and ready to use. Ley purchased another leaf pick up system that has been also installed on a mower.

New Business:

The Fence Ordinance that the Planning Commission approved to be presented to the Board was discussed. Ley made a motion to approve the Fence Ordinance, Miller supported.
