

## Concord Township Board Minutes

The Concord Township Board met in the Common Meeting Room August 10, 2015, at 7:30 P.M.

Members present: Supervisor Jamie Ley, Clerk Judy Clark, Treasurer Robert Jacokes, Trustees John Pardee & David Miller.

Absent: None

Also Present: Dorothy Cesco, Aaron Losey, Amanda Humphrey, Alexandria Knapp & Ed Fedorka.

The meeting was called to order by Supervisor Ley at 7:30 P.M.

Clark presented the board with the July 13, 2015 Concord Township Board minutes for approval. Jacokes made a motion to accept the minutes, Pardee supported. Motion carried.

Public comments:

None

Clark presented the Board with the July 2015 bills in the amount of \$6,734.24. Clark made a motion to pay the bills as presented. Miller supported. Motion carried.

Reports:

Jacokes gave the financial condition of the township, the revenues and expenditures for the month of July 2015.

Fire report was given by Clerk Clark due to the absence of Trustee Pardee at the Fire Board Meeting in July. Fire bills were paid at \$1,903.99, there is going to be a training for Extraction of Farm Implements with other departments attending to help offset the cost.

Clark gave the July 2015 police report with 46 complaints, 7 citations, 14 verbal warnings, and 5 arrests.

Ley made a motion to accept the reports as presented. Pardee supported. Motion carried.

Unfinished business:

Supervisor Ley has contacted Johnny's Tree Service to get another bid on the tree removal at the cemetery.

New Business:

Supervisor Ley asked Clerk Clark to present a Moratorium on the Definition of Fences, Walls and other Protective Barriers. After some discussion Ley made a motion to implement the Moratorium which is Ordinance #23. Clark supported. Roll call vote:

Motion carried.

Break in's at the cemetery were discussed with Supervisor Ley asking the Board for ideas how to secure the work garage.

Board Member Comments:

Clark read a letter from Roger L. Bowman asking permission to work on the oval sign that is in the Rosencrant's Flower Box at the Maple Grove cemetery which says, "Maple Grove, 1837, Concord. He has proposed to remove the existing oval sign, straighten and level the two support posts, repair the split in the sign, repaint the gold txt and green.

background and then reattach the sign using the existing brackets. After some discussion Miller made a motion to allow Mr. Bowman to take on the project, Pardee supported. Motion carried. Clerk Clark will notify Mr. Bowman to move forward with the project.

Clerk Clark has hired Brandon Ley to weed eat at the cemetery and asked the Board what they thought the salary should be. Clark suggested that we pay Brandon \$10.00 per hour and also suggested an increase of \$1.00 for Mr. Clark which will take him to \$11.00 per hour. Miller made a motion to pay the employees as presented, Jacokes supported. Motion carried.

Supervisor:

Supervisor Ley reported to the Board that the 2004 Police car is now at Chief Munster's home and he will use the vehicle for training the dog on Wednesday's. This way the car gets driven at least once a week to keep the brakes and tires from going bad.

With no other business at hand, Clark made a motion to adjourn, Ley supported. Motion carried.
