The Concord Township Board met in the Common Meeting Room July 14, 2014, at 7:30 P.M.

The new member appointed by Supervisor Ley to replace Damien Wetzel was Doug Terry, City Manager in Litchfield.

Ley reported that he had given the Police agreement to the Village Council on Tuesday, June 26, 2014. It was brought up at the Village Council meeting on Tuesday, July 8, 2014. There was some discussion on changes and Jeremy Bush is making the changes they discussed and then will be presented to the Township Board for review. Still having issues with the financials on the Police Savings Account, and the Village is aware and going to have help from auditor.

Pardee made a motion to accept the reports as presented. Coxon supported. Motion carried.
