## **Concord Township Board Minutes**

The Concord Township Board met in the Common Meeting Room December 8, 2014, at 7:30 P.M.

Members present: Supervisor Jamie Ley, Clerk Judy Clark, Treasurer Robert Jacokes, Trustees John Pardee & David Miller.

The meeting was called to order by Supervisor Jamie Ley at 7:30 P.M. and the Pledge of Allegiance was honored.

## Public comments:

Julie Alexander gave an update from the county level. Cascades renovations are to begin with the first phase of tearing down the wall on December 15, 2014. Street naming project is continuing. Department of Corrections Parolees worked on the Lime Lake Project. Central dispatch is still trying to get Lenawee County to join up with Jackson County.

Clark presented the board with the November 10, 2014 Concord Township Board minutes for approval. Ley made a motion to accept the minutes, Miller supported. Motion carried.

Clark presented the Board with the November 2014 bills in the amount of \$5,521.44. Clark made a motion to pay the bills as presented. Pardee supported. Motion carried.

## Unfinished business:

Supervisor Ley has talked with Ron Schafer, Village Council member about letting our Police Department have a breathalyzer and Radar that are not being used by the Village Police Department. Schafer said he would have to get with Dave Klein, Village Interim Police Chief.

## Reports:

Jacokes gave the financial condition of the township, the revenues and expenditures for the month of November 2014. Jacokes also reported on taxes collected to date.

Fire report was given by Pardee. Bills were paid in the amount of \$10,381.21. Ad was run in the Salesman for additional Fire Fighters. One application has been received. 6 new helmets were purchased. Repair/replacement of radios is underway. October breakfast put on by the Fire Club was a success. Kevin Lovitt notified the board that he had submitted his name for consideration to run for the at large member of the Fire Board.

Clark presented a budget revision Nancy Salvatore, Village Clerk had given her for the Capital Expense in the Fire Budget. Bob Jacokes made a motion to amend the Capital Expense from \$10,000 to \$79,253.49. Clark supported. Motion carried.

Clark reported that she and Chief Munster went to the Prosecutor's office and asked about them taking over the prosecution of ordinance and traffic violations. They are interested and going to draw up a contract for the Board to look at. This will alleviate billing problems at White & Hotchkiss, PLLC.

Ley made a motion to accept the reports as presented. Miller supported. Motion carried.
